

The Union Building & Loan, a division of Brentwood Bank Grand Opening Extravaganza Sweepstakes Official Rules.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

The following Sweepstakes is intended for legal residents of Pennsylvania only and shall only be construed and evaluated according to U.S. law. Do not enter this Sweepstakes if you do not reside in Pennsylvania at the time of entry.

ELIGIBILITY: The Union Building & Loan, a division of Brentwood Bank Grand Opening Extravaganza Sweepstakes (the "Sweepstakes") is open and offered only to legal residents of Pennsylvania who have reached the age of majority in their state of residence at the time of entry. Employees of Brentwood Bank their immediate families (parent, child, sibling or spouse) and/or household members and any other persons or entities associated with this promotion are ineligible to enter or win.

SPONSOR/ADMINISTRATOR: The Sweepstakes is sponsored & administered by Brentwood Bank 411 McMurray Road, Bethel Park, Pennsylvania 15102 (the "Sponsor" and "Administrator").

AGREEMENT TO OFFICIAL RULES: By participating, Entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes.

HOW TO ENTER: The Sweepstakes begins at 09:00:01 a.m. Eastern Daylight Time ("EDT") on June 10, 2019 and ends at 4:30:59 p.m. EDT on June, 14 2019 ("Sweepstakes Period"). The Sponsor's database computer is the official time-keeping device for the Sweepstakes. During the Sweepstakes Period, entrants must visit Union Building & Loan, a division of Brentwood Bank at 303 Leopard Lane, Bridgewater PA, 15009 during business hours, enter their name, phone number and e-mail address onto a raffle ticket and place into the ballot box. Upon submitting a raffle ticket Sweepstakes registration form, the Entrant will receive one (1) Sweepstakes entry. Limit one (1) entry per person per Daily Entry Period. All completed entries must be received by 4:30:59 p.m. EDT, on each day. The Sweepstakes will be divided into five (5) Daily Entry Periods (each, a "Daily Entry Period") each beginning at 09:00:01 a.m. Eastern Daylight Time ("EDT") and ending at 4:30:59 pm EDT, as shown in the tables below.

DRAWING AND NOTIFICATION: Administrator will conduct a random drawing from all eligible entries received from that respective Daily Entry Period to select potential winners for each Daily Prize, for a total of ten (10) potential Daily Prize winners during the Sweepstakes. Odds of winning a Daily Prize depend on the number of eligible entries received for each applicable Daily Entry Period.

Winners will be notified by phone number used to submit entry. If winners cannot be contacted within three (3) days after the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining entries.

The prizes must be picked up by winner at Union Building & Loan, a division of Brentwood Bank at 303 Leopard Lane, Bridgewater PA, 15009 after each winner is verified.

All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified. The Sponsor is not responsible for: late, incomplete, incorrect, delayed, garbled, undelivered, or misdirected entries. Sponsor reserves the right to disqualify any person or e-mail

address that submits more than maximum allowed entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.
